## INTRODUCTION

There are two components of the MCAP Government and LS MISA online testing system: the **MCAP Government and LS MISA Portal**, used by school and LEA administrators, and the **MCAP Government and LS MISA Kiosk**, used by students for testing. ### MCAP GOVERNMENT AND LS MISA PORTAL: BROWSER SPECIFICATIONS

The MCAP Government and LS MISA Portal is accessible via the following browsers on desktops and laptops:

- Chrome™ 108 or newer
- Firefox® 107 or newer
- Microsoft Edge™ 107 or newer
- Safari® 16 or newer

Administrators may access the MCAP Government and LS MISA Portal at any time during the administration.

### MCAP GOVERNMENT AND LS MISA KIOSK: STUDENT TEST DEVICE SPECIFICATIONS

Students may test on a device provided it meets the specifications provided in Table 1. A few important notes are included below:

- Students testing on devices that do not meet the Student Test Device Specifications are likely to encounter performance-related issues during testing.
- The MCAP Government and LS MISA Kiosk identifies third party applications that may cause interruptions during online test administration. Users will be required to close these prior to logging into the kiosk. There may be additional third-party applications not currently identified by the kiosk that can cause interruptions or interfere with the secure kiosk functionality. To minimize potential security issues and interruptions introduced by these applications, we recommend disabling such third-party applications from the devices prior to conducting the operational test.
- The practice test can be tested on the MCAP Government and LS MISA Kiosk or on a browser. If the student will require the use of text-to-speech for the practice test, they must test using the kiosk. If using the kiosk, launch the kiosk and click on the “Access the Practice Test” link on the sign in screen. All operational tests must be tested on the MCAP Government and LS MISA Kiosk.
- If a Chromebook™ was manufactured 2017 or later, it will not work in kiosk mode unless it is managed by an administrator. To run the Chromebook™ in kiosk mode, you will need a Chrome management license.

Color contrast, ASL video, and text-to-speech are accommodations embedded within the MCAP Government and LS MISA Kiosk. The other accommodations listed require the accommodated form be assigned to the student, but have no functionality embedded within the MCAP Government and LS MISA Kiosk. ## iTESTER AND 3<sup>RD</sup> PARTY ASSISTIVE TECHNOLOGY

iTester provides a rich suite of accessibility and accommodations features within the testing platform to assist students with special needs. Several external third-party accessibility hardware solutions and Microsoft Windows-based accessibility applications are also supported by iTester. Test coordinators should ensure the “Allow Accessibility Mode” (AAM) accommodation is turned on for all students who will require Windows-based third-party accessibility software. Note that this is only available in the Windows iTester Kiosk application. Owing to iTester’s secure kiosk feature and variability among assistive technologies, some assistive technology software *may not be* compatible with iTester, even with the “Allow Accessibility Mode Testing” accommodation activated. Some assistive software, including commonly used screen readers, *do not require AAM* to be used within the kiosk. Prior to operational testing, test coordinators must:

1. Ensure the student's assistive technology will work with iTester,
2. Determine whether the AAM accommodation must be activated to use the assistive technology, and
3. Provide the student an opportunity to practice using the assistive technology with the iTester Kiosk.

If the preferred third-party assistive technology does not work well with the iTester Kiosk Allow Accessibility Mode on, then consider using the third-party software on an external stand-alone device and transcribing the student’s answers into iTester in accordance with your state’s transcription policy. Allow Accessibility Mode reduces kiosk security controls to allow third-party software to operate in conjunction with the kiosk. If AAM is used, proctors should closely monitor students testing with this accommodation to ensure test security is not compromised.

iTester is developed in compliance with the World Wide Web Consortium’s (W3C) Web Content Accessibility Guidelines (WCAG) 2.1, Level AA for optimal compatibility with assistive technology products and features. As part of this effort, eMetric utilizes the W3C’s Accessible Rich Internet Application (ARIA) recommendation to improve the interaction between assistive technology and the testing platform. Any assistive technology products should comply with the User Agent Accessibility Guidelines (UAAG) and support the ARIA recommendation for the best user experience.

Some test content, such as Technology Enhanced Items, may not be fully WCAG compatible. Depending upon the test content provider and your state’s accessibility and accommodations policy, an alternate form or paper test may be required.

## MCAP GOVERNMENT AND LS MISA KIOSK DOWNLOAD AND INSTALLATION

The MCAP Government and LS MISA Kiosk will be available for download on October 24<sup>th</sup>, 2022.

### WINDOWS USERS

The MCAP Government and LS MISA Kiosk for Windows will be made available for download via the MCAP Government and LS MISA Portal. If your school uses Windows PCs, you will need to download and install the MCAP Government and LS MISA Kiosk. ### MAC USERS

The MCAP Government and LS MISA Kiosk for Mac will be made available for download via the MCAP Government and LS MISA Portal. If your school uses Mac, you will need to download and install the MCAP Government and LS MISA Kiosk. Step-by-step instructions for installing the MCAP Government and LS MISA Kiosk can be found in the MCAP Government and LS MISA Kiosk Installation Guide available on the Help & Support page: <https://maryland.onlinehelp.cognia.org>.

### LINUX USERS

The MCAP Government and LS MISA Kiosk for Linux will be made available for download via the MCAP Government and LS MISA Portal. If your school uses Linux workstations, you will need to download and install the MCAP Government and LS MISA Kiosk. Step-by-step instructions for installing the MCAP Government and LS MISA Kiosk can be found in the MCAP Government and LS MISA Kiosk Installation Guide available on the Help & Support page: <https://maryland.onlinehelp.cognia.org>. Remember that Linux cannot be used with TestMonitor and does not support text-to-speech.

### CHROMEBOOK USERS

The MCAP Government and LS MISA Chromebook app will be made available, if your school uses Chromebooks you will need to download it from the Chrome Web Store. Step-by-step instructions for installing the MCAP Government and LS MISA kiosk app can be found in the MCAP Government and LS MISA Kiosk Installation Guide available on the Help & Support page: <https://maryland.onlinehelp.cognia.org>.

**Note:** Any unmanaged Chromebooks released 2017 or later will not have the ability to test in kiosk mode. To run Chromebooks released after 2017 in kiosk mode, you will need a Chrome Management License. For more information, please follow the link listed below:

### iPAD USERS

The iTester app will be made available via the Apple iTunes App Store. If your building uses iPads for testing the single instance iTester app will need to be downloaded from the Apple iTunes App Store.

#### iTESTER TESTMONITOR

The iTester platform, called the MCAP Government and LS MISA Kiosk in Maryland, has been fine-tuned to account for a host of unique technology environments and constraints that exist in many schools, iTester's design ensures a seamless testing experience for all students, despite bandwidth limitations. To account for the extreme conditions that exist in some schools, iTester offers an optional caching module. The caching module helps to alleviate bandwidth issues in extreme, sub-par network conditions by utilizing the local network which translates into substantially lower downstream usage of the external internet connection.

Please note the MCAP Government and LS MISA Kiosk for Linux is not compatible with TestMonitor. Schools or LEAs using Linux operating systems will not be able to use TestMonitor.
